I am, by direction to inform that in the reference cited, the University has issued a set of comprehensive Instructions to the Management/Principals of all the Colleges of Education on the following aspects for strict implementations by the management of Colleges of Education, in order to enhance the Quality of teacher education in the State. They are:

- A. Submission of proposal for grant of qualification approval**
- B. Instructions to Managements of the Colleges of Education &**
- C. Instructions to the Faculty appointed**


But, of late, the University has been receiving complaints that some of the Colleges of Education have relieved their faculties in the middle of the academic year or even before completion of 2 years from the date of their appointment in their colleges and some other Colleges of Education have appointed teaching faculty in their Colleges in the middle of the academic year without any intimation to the University.

The act of such relieving and appointing the teaching faculties by Colleges of Education in the middle of the academic year or before completion of 2 years without prior intimation to the University is treated as a grave violation of the orders of the University. Further, such act in the middle of the academic year will deteriorate the process of maintenance of Quality of Teacher Education.

Hence, the Principals/Management of all the Colleges of Education are hereby, once again, strictly instructed to follow the comprehensive instructions issued in the reference cited scrupulously and the failure will be viewed seriously in the interest of maintaining quality of teacher education in the affiliated colleges of this University.

In addition to the above, the Principals/Managements of all the Colleges of Education are instructed to refer to the NCTE's notification dated 29.05.2017, which was published at page Nos: 20 & 21, Part III-Sec.4 of "The Gazette of India-Extraordinary" dated 09.06.2017. Accordingly, *Asst. Professors having the eligibility qualification of NET/SLET or Ph.D degree alone are entitled for the appointment of Assistant Professors for Teacher Education Programmes (B.Ed/M.Ed/B.Sc.B.Ed).*

As per the decision taken by the SRC/NCTE in the 357th meeting held on 23-24.02.2017, the qualification of NET/SLET or Ph.D for appointment of Asst. Professors is enforced with effect from 23.02.2017. These instructions may kindly be taken note of and strictly implemented in future appointment of Asst. Professors in the Colleges of Education.
