The UGC in its 536th Commission meeting held on 14th November, 2018 has resolved that all such colleges/institutions which intend to apply for inclusion under Section 2(f) and 12(B) of the UGC Act, 1956 shall upload all the details of their college on their official website before applying for the same. The college is required to update their website regularly. UGC may check the details provided by the college on their website anytime. If any college included under Section 2(f) and 12(B) is found uploading wrong information, the Commission may take such action as it may deem fit.

The college which intends to apply for inclusion under Section 2(f) and 12(B) of the UGC Act, 1956 shall also submit their proposal through their affiliating University. The University shall forward the proposal with covering letter in the University's letter head duly signed by the Registrar.
