

The Southern Regional Committee of National Council for Teacher Education (NCTE) in exercise of the powers vested under Section 14(3)(a) of the NCTE Act 1993 has granted recognition to Tamil Nadu Teachers Education University, Karapakkam, Chennai for conducting M.Ed Programme of two year duration with an intake of 50 students (1 unit) from the academic year 2017-2018.

The Regional Director and OSD, Southern Regional Committee, NCTE has communicated the decision of the NCTE in the letter dated 02.05.2017. It is a significant and appreciable progress of the University that it will be involving in teaching activities also, apart from study and research.

An Admission Committee has been constituted with three faculty members to work out and evolve procedures for admission of students, advertisement, format of application, arrangements of classrooms, teaching assignments and such other requirements to offer two year M.Ed Degree Programme from the academic year 2017-2018 at this University.

The two-year M.Ed Degree Programme would be offered as per the existing Curriculum, Regulations and Syllabi of this University for the M.Ed Degree Programme.

The University would also request the NCTE for additional intake gradually to increase the teaching activities in the University.

Dr.M.Govindan will move that the two year M.Ed Degree Programme be offered as per the existing Curriculum, Regulations and Syllabi for the M.Ed Degree Programme at the Tamil Nadu Teachers Education University from the academic year 2017-2018 and thereafter, after making all the required arrangements and putting in place required infrastructure for the conduct of two year M.Ed Degree Programme. This is a significant and appreciable progress and the Vice Chancellor be authorized to approve all the academic and administrative procedures including teaching assignments to offer the course besides approaching the NCTE for additional intake gradually for the two year M.Ed Degree Programme.

Item No. 2

The Southern Regional Committee of National Council for Teacher Education (NCTE) in exercise of the powers vested under Section 14(3)(a) of the NCTE Act 1993 has granted recognition to Tamil Nadu Teachers Education University, Karapakkam, Chennai for conducting M.Ed Programme of two year duration with an intake of 50 students (1 unit) from the academic year 2017-2018. The Regional Director and OSD, Southern Regional Committee, NCTE has communicated the decision of the NCTE in the letter dated 02.05.2017.

As the two year M.Ed Degree Programme has to be offered from the academic year 2017-2018 at the University, the Vice Chancellor as a first step constituted a Committee to evolve fee structure for the two year M.Ed Degree Programme.

The Committee met on 06.06.2017 and submitted the following minutes.

"The Committee collected information on M.Ed Degree Programme fee structure from the University of Madras, Madura Kamaraj University, Periyar University and Bharathiyar University which offer M.Ed Degree in full-time and regular basis, including the fee structure fixed for the Government Colleges of Education.

Accordingly, the Committee compared the fee structures of the University of Madras and Madurai Kamaraj University and has recommended a moderate fee structure in between the University of Madras and Madurai Kamaraj University taking into consideration to offer the M.Ed Degree Programme to the students from economically weaker sections."

The recommendations of the above Committee have been placed before the Finance Committee held on 19.06.2017 which resolved as follows:

"Resolved to recommend that the proposal be accepted with the following fee structure for two year M.Ed Degree Programme from the academic year 2017-2018.

Business Brought forward by the Vice Chancellor

Item No. 1

The Southern Regional Committee of National Council for Teacher Education (NCTE) in exercise of the powers vested under Section 14(3)(a) of the NCTE Act 1993 has granted recognition to Tamil Nadu Teachers Education University, Karapakkam, Chennai for conducting M.Ed Programme of two year duration with an intake of 50 students (1 unit) from the academic year 2017-2018.

The Regional Director and OSD, Southern Regional Committee, NCTE has communicated the decision of the NCTE in the letter dated 02.05.2017. It is a significant and appreciable progress of the University that it will be involving in teaching activities also, apart from study and research.

An Admission Committee has been constituted with three faculty members to work out and evolve procedures for admission of students, advertisement, format of application, arrangements of classrooms, teaching assignments and such other requirements to offer two year M.Ed Degree Programme from the academic year 2017-2018 at this University.

The two-year M.Ed Degree Programme would be offered as per the existing Curriculum, Regulations and Syllabi of this University for the M.Ed Degree Programme.

The University would also request the NCTE for additional intake gradually to increase the teaching activities in the University.

Dr.M.Govindan moved that the two year M.Ed Degree Programme be offered as per the existing Curriculum, Regulations and Syllabi for the M.Ed Degree Programme at the Tamil Nadu Teachers Education University from the academic year 2017-2018 and thereafter, after making all the required arrangements and putting in place required infrastructure for the conduct of two year M.Ed Degree Programme. This is a significant and appreciable progress and the Vice Chancellor be authorized to approve all the academic and administrative procedures including teaching assignments to offer the course besides approaching the NCTE for additional intake gradually for the two year M.Ed Degree Programme.

Vice Chancellor: Now let us move to the second item. For the introduction of two-year M.Ed Degree Programme, we have evolved a fee structure to be collected from

Business Brought forward by the Vice Chancellor

Item No.2

The Southern Regional Committee of National Council for Teacher Education (NCTE) in exercise of the powers vested under Section 14(3)(a) of the NCTE Act 1993 has granted recognition to Tamil Nadu Teachers Education University, Karapakkam, Chennai for conducting M.Ed Programme of two year duration with an intake of 50 students (1 unit) from the academic year 2017-2018. The Regional Director and OSD, Southern Regional Committee, NCTE has communicated the decision of the NCTE in the letter dated 02.05.2017.

As the two year M.Ed Degree Programme has to be offered from the academic year 2017-2018 at the University, the Vice Chancellor as a first step constituted a Committee to evolve fee structure for the two year M.Ed Degree Programme.

The Committee met on 06.06.2017 and submitted the following minutes.

"The Committee collected information on M.Ed Degree Programme fee structure from the University of Madras, Madura Kamaraj University, Periyar University and Bharathiyar University which offer M.Ed Degree in full-time and regular basis, including the fee structure fixed for the Government Colleges of Education.

Accordingly, the Committee compared the fee structures of the University of Madras and Madurai Kamaraj University and has recommended a moderate fee structure in between the University of Madras and Madurai Kamaraj University taking into consideration to offer the M.Ed Degree Programme to the students from economically weaker sections."

The recommendations of the above Committee have been placed before the Finance Committee held on 19.06.2017 which resolved as follows:

"Resolved to recommend that the proposal be accepted with the following fee structure for two year M.Ed Degree Programme from the academic year 2017-2018.

The Syllabus was first prepared in the Semester pattern because it was started late on account of some reasons and we have fulfilled the requirements of the NCTE to work for 250 days. The semester pattern could not be carried out for all the 4 years. So in the previous Syndicate Meeting, it was decided to convert the Semester pattern into non-semester pattern for the whole batch of the first year students who have joined in the academic year 2016-2017.

Then the Board of Studies has prepared Syllabus for 1st year 2016-2017 batch of 4-year integrated B.Sc.B.Ed Degree Programme (Non-Semester). The Board has also prepared syllabi for the 2nd year 2016-2017 batch of 4-year Integrated B.Sc.B.Ed Degree Programme (Non-Semester) and Syllabi for 2nd Year 2017-2018 batch of 4-year Integrated B.Sc.B.Ed Degree Programme (Semester). Now, this syllabi are placed before the Academic Council.

Now, I request Dr.N.Muthaiah the Chairperson of the 4-year integrated degree programme to move the Item No.3.

Dr.N.Muthaiah: Most respected Vice Chancellor, the Registrar and other Hon'ble Members. Before moving the resolution, I would like to make a point that this kind of unique venture is attempted by our Tamil Nadu Teachers Education University for introducing 4-year integrated programme in teacher education. So, I extend my earnest thanks and my congratulations to our Vice Chancellor, Registrar and all Professors for venturing into the unique attempt of introducing a new structure of the programme as per the guidelines of the NCTE. The Syndicate at its meeting held on 19.01.2017 has approved the above Minutes of the Academic Council as Item No.22.

The meeting has decided the question paper pattern for the theory examination and structure for practical examinations.

The meeting has decided to conduct the practical examination in the month of July 2017 by inviting Professors, in the concerned subject from Arts and Science Colleges."
