**The University is advised to participate in NIRF ranking and get NAAC accreditation at the earliest.**

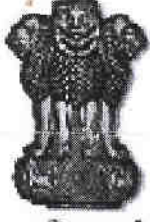
**The faculty sanctioned and in position should be as per concerned statutory council(s)/ UGC norms in all the Departments.”**
